Dr. Close began by congratulating Ms. Arty on being elected the Secretary of the National Association of Executives and Regulatory Boards.

## **ADMINISTRATIVE REPORT**

Ms. Arty, Executive Director reported, she and Dr. Close had the privilege of traveling to the Conference Board, which had very valuable information.

The Delmarva Association called to say they were having problems on the Eastern Shore with death products insurance that was not being accepted by Social Security. They invited Ms. Arty to teach pre-need, CEU and talk about the Irrevocable Assignment form.

The licensing period for those people who were on a one year cycle is almost over. We have gotten many phone calls regarding CEU's. When a licensee renews, they must

prove that the CEU requirements (12 CEU's per renewal cycle) have been fulfilled. When morticians' licenses were renewed in 2012, they used CEU's earned from May 1, 2010- April 30, 2012. This renewal cycle 6 CEU's are due earned between May 1, 2012- April 30, 2013, no pre-need and no more CEU's due until renewal in 2015.

As you know this Board has instructed the Staff to be available and to educate licensees in the last couple of years. In the coming years, the Board will not be concentrating on the education of licensees; the concentration will be on the consumer. There will be various public speaking events to consumers, so they are educated and we are all on the same page.

Lynn Newman, Chair, then reported that we have been closely watching the ownership and beneficiary of insurance policies, and there have been a couple of morticians' deaths that have involved ownership of the policies, where their personal representatives have closed their estates. We are looking at what direction we can take in order to help these consumers get their pre-need funds back.
