- **CE Committee Report -Current CE's Approval Recommendations**
(Dr. Michael Moskowitz, Chair-Adrienne Congo reports in his absence).
 - *JHU Opioid Courses- Committee has recommended to the Board to accept the course as an approved course.*
 - *Dry Needling New Instructor/Course- Dr. Jason Hulme submitted a CEU course review packet for Board approval regarding "Dry Needling with Advanced Applied Neuromuscular Principles". Dr. Gregory Lewis moves to accept the coursework; Dr. Kindra Ingram 2nd. Passed. Dr. Ingram inquires as to the necessity to approve courses from Johns Hopkins University since accredited Maryland Colleges come under the pre-approved provider status.*


