2 **State Board for Certification of Residential Child Care Program Professionals –**
3 **Revisions**

4 FOR the purpose of repealing an erroneous provision of law regarding immunity from
5 liability for participating in the activities of the State Board for Certification of
6 Residential Child Care Program Professionals; repealing the requirement that the
7 Board adopt certain regulations for approved training programs for residential child
8 and youth care practitioners; repealing the requirement that the Board post a list of
9 approved residential child care training programs on its website; making a
10 conforming change; and generally relating to the State Board for Certification of
11 Residential Child Care Program Professionals.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Health Occupations**

4 [20–207.

5 A person shall have the immunity from liability described under § 5–710 of the
6 Courts Article for giving information to the Board or otherwise participating in its
7 activities.]

8 [20–208.] **20–207.**

9 A person shall have immunity from the liability described under § 5–723 of the
10 Courts Article for giving information to the Board or otherwise participating in its
11 activities.

12 20–302.1.

13 (f) (1) Except as provided in paragraph (2) of this subsection, the applicant
14 shall have successfully completed a training program approved [under § 20–302.2 of this
15 subtitle] **BY THE BOARD.**

16 (2) (i) An applicant who has an associate’s or bachelor’s degree from an
17 accredited college or university may be waived from the training program requirement, if
18 the applicant passes an examination and meets other requirements established by the
19 Board under this subtitle.

20 (ii) The Board shall establish requirements and procedures for
21 waiving the training program requirement for an applicant under subparagraph (i) of this
22 paragraph.

23 [20–302.2.

24 (a) The Board shall adopt regulations for approved training programs for
25 residential child and youth care practitioners.

26 (b) Successful completion of an approved training program shall prepare an
27 individual for certification as a residential child and youth care practitioner.

28 (c) The regulations shall:

29 (1) Require an approved training program to provide a fundamental
30 working knowledge of the varied aspects of performing the direct responsibilities related to
31 activities of daily living, self–help, and socialization to children and youth in residential

1 child care programs;

2 (2) Establish a process for approving residential child and youth care
3 practitioner training programs; and

4 (3) Establish the contact hours, curriculum, format, and fees for approved
5 training programs.

6 (d) The Board shall post a list of approved training programs on its Web site.]

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2018.
