Deputy Secretary's Opening Remarks

- The DDA's highest priority is the health, safety, and wellbeing of people with intellectual and developmental disabilities, their families, staff, and providers
- The DDA is committed to transparency with all of our stakeholders to ensure we are all working with the same information to support our shared missions
- Thank you for your continued support in joining me during these webcast so that we can stay in-touch and be able to provide you with the most current information

- Governor Larry Hogan lifted the outdoor mask mandate and all restrictions for outdoor dining. He also announced that the State has entered a new phase of its vaccination campaign, moving to direct scheduling at mass vaccination sites and continuing to expand points of distribution
- **DIRECT SCHEDULING AT MASS VACCINATION SITES-**Beginning Saturday, all eligible Marylanders can immediately book an appointment to receive a COVID-19 vaccine by visiting covidvax.maryland.gov or by calling Maryland's COVID-19 Vaccination Support Center at 1-855-MD-GOVAX (1-855-634-6829)

- MASS VACCINATION SITES- 12 mass vaccination sites are open and fully operational across the state. The 13th and final site is opening in Howard County this Friday, April 30, at the Mall in Columbia and is anticipating a record opening day of 1,000 vaccinations
- NO ARM LEFT BEHIND-Individuals in need of additional assistance to get vaccinated including homebound and those in need of transportation can call Maryland's COVID-19 Vaccination Support Center at 1-855-MD-GOVAX (1-855-634-6829). The call center is available seven days a week from 7 a.m. to 10 p.m



- Governor Hogan's Order regarding Certain Businesses and Facilities and Generally Requiring Use of Face Coverings
 - Effective immediately, face coverings are no longer mandated when individuals are outdoors except for outdoor venues
- <u>Directive and Order Regulating Certain Businesses and Facilities &</u>
 <u>General Directives Concerning Limiting The Spread of COVID-19</u>
 - As of 12:01 am, May 1, 2021 all restrictions related to outdoor dining will be lifted
- MDH Amended Various Healthcare Matters
 - Extends hospital surge/patient transfer section until June 30, 2021



Recovery for the Economy, Livelihoods, Industries, Entrepreneurs, and Families (RELIEF) Act

- During our last webinar we shared that the DDA and the Maryland Community Health Resources Commission (CHRC) announce the Emergency Relief Call for Proposals for Title 7 Developmental Disabilities Administration Providers. Last Friday, we shared the <u>Frequently Asked Questions</u>
- The grant funds are to support one-time only uses to ensure service delivery, in accordance with the provision of the Relief Act focused on re-opening, transformation, or revenue loss
- Applications are due to the CHRC no later than May 10, 2021

 - RFP Application Form
 - Grant Obligations & Assurances
 - <u>Budget Form Template</u>
 - Budget Narrative Template


Reopening

- Our providers are leading discussions for the 'how and when' to reopen and resume in-person community services. Their careful planning is guided by a number of factors including individual and family interests and readiness, program and staffing capacity, transportation, and early provider experiences with scaled back openings this spring

 years of age or older VACCINE REGISTRATION






DDA Tracking

POSITIVE PARTICIPANTS BY REGION WEEK ENDING 4/29/2021





There have been 2,023 participants reported as having tested positive for COVID-19 of which there have been 102 deaths.




The 102 deaths represents approximately 5% of all (2125) participants that tested positive.


PARTICIPANTS IN SELF-DIRECTION WEEK ENDING 04/29/2021

Vaccination Tracking




- Of the 15,560 participants that the agencies reported intending to have vaccinated, 11,077 (71%) have been vaccinated, 4,483 (29%) have not received a vaccine
