

- 3. The CCS will complete and submit the DDA Cost Detail Tool with the PCP. The Cost Detail Tool includes all available services and associated rate based on the traditional service delivery model. Annually, if approved by the General Assembly, the DDA applies a Cost of Living Adjustment (COLA) to traditional service rates which is updated in the Cost Detail Tool. The required use of the Cost Detail Sheet for both participants using the self-directed and traditional service delivery models ensure fair and equitable funding regardless of the service model chosen.;
- 4. The CCS submits the Person-Centered Plan with the Cost Detail Tool to the DDA Regional Office for approval.; and
- 5. Once the PCP and Cost Detail Sheet is approved by the DDA, the participanterson can then create or finalize their self-directed budget sheet and determine pay rates based on reasonable and customary program standards.

Effective January 1, 2021, during the initial, revised, and annual PCP planning processes, the participant's self-directed budget will be determined based on the approved LTSSMaryland PCP detailed service authorization.
