2020 Online License Renewals

Please check if the expiration date on your license is October 31, 2020. If so, you will be able to go to the Board's website at www.health.maryland.gov/dietetic starting September 9, 2020 to renew your license.

You may renew online between September 9, 2020 - October 31, 2020. Please note there is no late renewal

The Board has transitioned to paperless licensure. You will not receive a license in the mail. However, you will receive an email notification that your license has been renewed. Online verifications are available at www.health.maryland.gov/dietetic

Before you begin, you will need the following:

Your Maryland Board of Dietetic Practice License Number and Social Security Number.

Computer or laptop and a printer. You will print a copy of your application and invoice or receipt for your

Continuing education records.

Visa or MasterCard only (no debit cards accepted). You may also mail a check or money order with a copy of the online receipt to the Board.

To Renew Online:

Go to the Board's website at www.health.maryland.gov/dietetic and click RENEW ONLINE.

Read the instructions and click **LOGIN** to proceed to the Logon Screen. Enter your Board of Dietetic Practice License Number – **D**, **DX**, **B**, **THEN THE NUMBER**. 3. (i.e., D Zero ####).

Enter the last 4 digits of your Social Security Number.

Fill in the information as requested. (Note that some fields may already be completed) Please note that when you renew online, no paperwork is required. You will list a minimum of 30 CEUS electronically by category between November 1, 2018 - October 31, 2020. The Board will conduct a random audit after the

Prior to selecting a method of payment, you must certify that all information in the application is accurate.

Preview your application and then click, Submit Application. Please note that once submitted the application cannot be changed. Print and maintain a copy of your application for your records.

Payment Methods:

Select Visa or MasterCard credit card payment. The 2020 renewal fee is \$250. Only click once to con-

firm payment. Applications will be processed within 1-2 business days. OR

Select PAYMENT BY MAIL. You may mail a check or money order in the amount of \$250 made 2. payable to the Maryland Board of Dietetic Practice. Your license will not be processed until payment is received. The Board must receive payment on or before October 31, 2020. The mailing address is the Board of Dietetic Practice, 4201 Patterson Avenue, 3rd Floor, Baltimore, MD 21215-2299.

A new Executive Order issued June 19th applies to the extension of licenses. The expiration date is extended "to the 30th day after the date by which the state of emergency is terminated". According to the new Executive Order, the state of Emergency is still in effect. The Board has no prediction as to when the state of emergency will be

The Board encourages you to renew your license by October 31, 2020. However, according to this Order, if you do not renew, you will not be treated as unlicensed or practicing without a license at this time.

INACTIVE STATUS

If you are an active licensee and do not plan on renewing your license and do not plan on practicing in Maryland, you may consider inactive status. The one time fee for inactive status is \$75. Inactive status allows an individual, who wishes to practice in Maryland again, to reactivate a license by demonstrating 15 CEU for each year the license has lapsed. The reactivation fee is \$150. You may download the inactive status application from the Board's website at www.health.maryland.gov/dietetic

ELIMINATION OF LATE FEE

Reminder: **The late fee has been eliminated.** Therefore, individuals who do not renew by October 31 must reinstate their licenses and may not practice dietetics in Maryland. The reinstatement fee is \$576 this year. You may check the expiration date of your license available via the Board's website at www.health.maryland.gov/dietetic. Click on "Verify a License."

If you do not plan to renew your license, you may consider placing your license on inactive status for a one-time fee of \$75. You may download the Inactive Status Application via the Board's website. Click on "Forms."

Please renew your license on time.

2020 Renewal Fee and Health Care Commission Fee

The 2020 renewal fee is \$250. The Health Care Commission fee is \$26 for 2020. The Board will again pay for the \$26 HCC fee for licensure renewals.
