Approval of Minutes

The minutes for the November 19, 2020 meeting were approved as written.

ITEM 2

Committee Reports

Budget -

Ms. Savage provided an update on the 2020 renewals. The Governor's Executive Order issued June 19, 2020 regarding the extension of licenses is still in effect. The expiration date is extended "to the 30th day after the date by which the state of emergency is terminated". The Board has no prediction as to when the state of emergency will be

lifted. There were 1,068 licensees eligible for renewal. 861 licensees renewed in 2020 and 3 licensees renewed to date in 2021. The Board has already issued 207 new licenses in Fiscal Year 2021 (July 1, 2020 – June 30, 2021). The Board has a record high for new licensees and renewals.

Credentialing -

Regulations/Legislation -

The Board reviewed MAND's Letter to Board requesting telehealth and dietary order regulations. The Board indicated that they will not pursue telehealth regulations at this time since telehealth legislation has been introduced during this legislative session. The Board will monitor the telehealth legislation and will consider telehealth regulations after session. As far as dietary order regulations, the Board is not authorized to promulgate regulations on dietary orders since the practice of order writing and verbal orders is not specifically included in the definition of "practice dietetics." Dietary orders are not prohibited by the law and the Board recognizes that it is commonly used in the practice of dietetics. At this time, the Board suggests that facilities develop a written policy that identities the appropriate training, staff and documenting procedures for these activities.

The Board reviewed the following legislation:

- SB 262 (HB 224) Department of Information Technology Study of a Common Information Technology Platform for Health Occupations Boards. No Position – The Board will monitor this bill.
- SB 72 Open Meetings Act Requirements for State Agencies and Local Board of Elections. Letter of Concern – The Board had concerns regarding potential misuse of material, technological capability and the fiscal impact.
- 3. SB 5 (HB28)) Public Health Implicit Bias Training and the Office of Minority Health and Health Disparities Letter of Support
- 4. HB 123 (SB 3) Preserve Telehealth Access Act of 2021. No Position The Board will monitor this bill.
