ITEM 1

Approval of Minutes

The minutes for the March 18, 2021 meeting were approved as corrected. Ms. Duru was in attendance at the March 18, 2021 meeting.

ITEM 2

Committee Reports

Budget -

2020 Renewal and Governor's Emergency Order

Ms. Savage provided an update on the 2020 renewals. Due to the COVID-19 pandemic, the Governor's Emergency Order extended the expiration date of health occupation licenses for 30 days after the expiration of the Emergency Order. Only if your license had an October 31, 2020 expiration date, you were granted an extension for licensure renewal. The Governor has lifted the Emergency Order on June 1, 2021. Therefore, licensees who had an October 31, 2020 expiration date and have not already renewed their licenses are required to renew by June 30, 2021 in order to practice dietetics in Maryland.

On July 1, 2021, if a licensee had an October 31, 2020 expiration date and did not renew, the online database will no longer list the individual as "active," but will switch the status to "non-renewed." Regardless of when a licensee renewed in the 2020 renewal cycle, the expiration date will be October 31, 2022. Online renewals for 2021 (Licensees with October 31, 2021 expiration date) will begin online renewals on September 8, 2021.

There were 1,068 licensees eligible for renewal. 877 licensees renewed in the 2020 cycle. The Board has issued 310 new licenses in Fiscal Year 21. The Board has a record high for new licensees and renewals.

Transfer of \$22,646 to the Maryland Health Care Commission

On May 6, 2021, the Board transferred \$22,646 to the Maryland Health Care Commission. The MHCC fee is \$26 for the 2021 renewal cycle. The Board will absorb the MHCC fee. Therefore, the 2021 renewal fee will be \$250.

Regulations/Legislation -

Miss Reese, Board Legislative and Regulatory Liaison, provided an update on 2021 legislation of interest to the Board including the following legislation:

- SB 262 (HB 224) Department of Information Technology Study of a Common Information Technology Platform for Health Occupations Boards. No Position – The Board will monitor this bill. The legislation passed and takes effect on July 1. It requires a study of the health occupation boards IT systems by DoIT.
- 2. SB 5 (HB28)) Public Health Implicit Bias Training and the Office of Minority Health and Health Disparities Board submitted a Letter of Support. The legislation requires a one-time CEU by 4/1/22. House Bill 28 passed and takes effect on October 1.

3. HB 123 (SB 3) Preserve Telehealth Access Act of 2021. No Position – The Board monitored this bill. The legislation passed but doesn't affect the Board. It deals with telehealth and Medicaid.
