Dr. Stephanie Chaney called the meeting to order at 10:00 A.M.

## **Review of Agenda and Minutes**

The January 12<sup>th</sup> Agenda was amended as follows: 1) under no. 6, add "b. Mid-Atlantic Spinal Rehab and Chiropractic – Marc G. Gulitz, D.C."; and add "c. Absolute Chiropractic Care, LLC – Katherine A. Poe, D.C."; 2) under no. 7, add "f. Touched by Autumn Massage Therapy by Adrianne Williams, RMP – Adrianne L. Williams, RMP"; add "g. Virtuous Wellness Center (Amy L. Owens, LMT) – Amy Lynn Owens, LMT"; add "h. Heal Relax Restore with Suzanne Stamp, LMT – Suzanne Stamp, LMT"; and add "i. MASSAGE BY DAVID COX, David A. Cox, LMT – David Allen Cox, LMT"; 3) renumber and add no. 8, "Issue Regarding Practice Purchase and Utilizing Trade Name – Dr. Fedorczyk"; and 4) add no. 9, "Preceptor Petition – Brian Paris, D.C." Ms. Hucek motioned to accept the amended Agenda; Ms. Jolivet seconded, and the motion was unanimously voted.

The December 8, 2011 Minutes were approved as drafted. Dr. Sadula motioned to accept the Minutes; Dr. O'Hara seconded, and the motion was unanimously voted.

## Review of Administrative Staff Issues, Mr. J.J. Vallone, Executive Director

▶ Budget Update and Upcoming Training: The Board is on track in terms of income and expenditures. Mr. David Ford will attend the ACFE Conference; paid by Board funds. Dr. Chaney and Dr. Fedorczyk will attend the FCLB and NBCE Conferences scheduled for May 2012 in San Antonio, TX.

- The Board Office has two staff members on medical leave for the next couple of weeks. Remaining staff will pitch in, as necessary.
- Ms. Michelle Czarnecki is back in law school full time and will work (at her current contract fee) 1½ days per week, assisting Board Counsel with legal matters and assisting the Chiropractic Board Office, as needed. Ms. Czarnecki graduates the spring of 2012.

#### Petition from Ms. Amber Davis, C.A. Trainee

Ms. Davis petitions the Board to allow her to reinstate in the Chiropractic Assistant (C.A.) Training Program. Ms. Davis had previously been granted a one-year extension to complete her C.A. training while working in the office of Dr. Eric Huntington and Dr. Lauren Cohen (Living Wellness Chiropractic). Ms. Davis was terminated from the employ of Dr. Huntington and Dr. Cohen (due to interactions with another employee) before she could complete her training and take the State C.A. examination. The next available course for which Ms. Davis could have enrolled began after her termination—which did not allow her to begin the 2010 C.A. classes. Dr. Huntington and Dr. Cohen re-hired Ms. Davis as a receptionist, over a year ago, and consider her an asset to the C.A. profession; they support her reinstatement request. Ms. Davis has completed her 40 hours of observation and her 480 hours of inservice training. The Board motioned to approve Ms. Davis' petition for reinstatement into the C.A. Training Program. Dr. O'Hara supported the motion; Ms. Hucek seconded, and the motion was unanimously voted.

### **Appointment of Board Disciplinary Review Committee**

A Board Disciplinary Committee reviews all incoming complaints, conducts a preliminary review for jurisdiction and efficacy, and determines initial routing disposition of every complaint. The following guidelines will commence in effect on January 1, 2012: 1) The Committee will consist of one active chiropractor, one licensed massage therapist, one consumer member, and the Executive Director (Board Counsel will serve as legal advisor); 2) Members will be appointed by the Board President for six-month rotating terms; 3) When complaints are received, the Executive Director will assign an identifying designator that is not the official case number; 4) The Executive Director will conduct an initial administrative/jurisdictional review to determine the legibility jurisdictional efficacy of the complaint; 5) The Executive Director may return the complaint to complainant to resolve legibility or ambiguity issues and may seek legal advice; 6) If no such issues exist, the complaint is forwarded, via E-mail, to the Committee with a short summary/recommendation. Identity of the complaint subject will not be disclosed at any time; 7) The Committee will vote to: a) forward the case for investigation; b) dismiss the case for lack of jurisdiction, clarity, and factual basis; or c) vote to table the case for further review. The majority vote will rule. In the event of a tie, the case will be assigned for investigation to protect public interests; 8) The Committee will endeavor to submit their vote within 72 hours of receiving the initial Email from the Executive Director; and 9) If forwarded for investigation, the Senior Investigator will assign a formal accession case number and commence investigation proceedings. The Board President, Dr. Chaney, appointed Dr. Kay O'Hara, Ms. Gwenda Harrison, (Licensed Massage Therapist), and Ms. Mary Anne Frizzera-Hucek (Consumer Member) to serve for a six-month term (January – June 2012).

## <u>Issue Regarding Practice Purchase and Utilizing Trade Name – Dr. Fedorczyk</u>

Dr. Fedorczyk presented the issue of whether or not a chiropractor can continue utilizing the same trade name once he/she has purchased a practice from another chiropractor. Also, should a retired chiropractor's name continue to be part of signage, advertising, etc? This issue is deferred to the Board Counsel for legal review/advice.

## Preceptor Petition – Brian Paris, D.C.

Dr. Paris submitted a Preceptor Application to allow him to participate in the Externship Program. Dr. Fedorczyk and Mr. David Ford will conduct a comprehensive review of Dr. Paris' office/staff and report their findings back to the Board.
