#### Call to Order at 10:11 a.m. & Opening Remarks by Board Chair

The regularly scheduled Open Session meeting of the Maryland State Board of Massage Therapy Examiners was held at the Metro Executive Building, Conference Room 110, on February 26, 2020. The meeting was called to order at 10:11 a.m. by Paula Jilanis, LMT and Board Chair. Roll call was taken and all Board Members were present.

Review/Approval of the Open Session Agenda with additions/amendments – Gwenda Harrison motioned to accept the agenda with additions; 2<sup>nd</sup> by Caitlin Thompson; The motion passed. Board Vote: 7/0/0.

Review/Approval of the Open Session Minutes for January 22, 2020 – David Cox motioned to accept the Open Session Minutes; 2<sup>nd</sup> by Kirsten Bodnarchuk. The motion passed. Board Vote: 7/0/0.

#### **Board Chair Reports**

FARB Conference (January 23-27, 2020, in Colorado Springs, CO) – Paula Jilanis and Sharon Oliver attended the FARB conference. Topics discussed included: Moral Turpitude, Moral Character, Model Practice Act as it compares to current Laws & Regulations, Sanctioning Guidelines, Reporting Convictions in a timely fashion, Definition of License Lapse, and Consistency of Implementation of Policy & Procedures.

AMTA Schools Summit (February 12-15, 2020, in Los Angeles, CA) — Paula Jilanis and Sharon Oliver attended the AMTA Summit. Topics at the AMTA Summit workshops: Debunking



the myth of learning styles, Teaching Pain Management in all Environments, Advanced Skills for Teaching Adult Learners, How to Attract Learners using Social Media, Business Strategies, Niche Marketing & The Science of Self-Care. The State of California currently doesn't require students to take the MBLEx (there is a temporary moratorium in effect). Paula Jilanis would for like the Board to consider having an information table at the AMTA Summit in 2021.

**Bylaws** –Motion by David Cox to begin a discussion to open the Bylaws for review; 2<sup>nd</sup> by Diane Jones-Richards. The motion passed. Board Vote: 7/0/0.

**Bylaws Discussion:** After the discussion, Gwenda Harrison motioned to open the Bylaws to review Strategic Planning and Inclusion, clarification of the legal interpretation of the Board Chair's role to withhold information, and a clear, step-by-step process description for the hiring and firing of the Executive Director. There was no 2<sup>nd</sup> The motion failed.

Strategic Planning – The Board is scheduled to meet on Thursday, July 23, 2020 to work on a revision of the Strategic Plan. Meeting location and time will be determined by the next Board meeting.

Montgomery County, Maryland Bill – The Board does not support the proposed Montgomery County Bill. On February 25<sup>th</sup>, Paula Jilanis and Amelia Mitchell, AMTA, attended a hearing sponsored by the Health and Human Services Committee.

#### General Counsel

Moral Turpitude - Grant Gerber suggested incorporating Health Occupation 608 with regards to Moral Turpitude into our Statues. Board Counsel and the Advisory Committee are tasked with reviewing the statute.

**Board Oversight** – The Massage Board is statutorily independent with respect to decision making regarding discipline. Actions of the Board may be reviewed by the Office of Administrative Hearings (OAH). Oversight and Antitrust protection are available to all Board Members.

## **Executive Director's Report**

Reminder - Check emails daily during Legislative Session - Board members were reminded to review emails daily.

SB0067 (HB0042 Cross): Public Information Act – Applications for Inspection –Responses and Time limits. – Many Boards, including Massage are in opposition to this Bill.



SB0297 (HB483 Cross): Administrative Procedure Act – Dispositions and Summary Suspensions – The Massage Board has opposed this Bill.

HB0751: State Board of Massage Therapy Examiners – License and Registration – Criminal History Records Checks. Vice Chair Caitlin Thompson testified on The Rap Back Bill on behalf of the Massage Board.

**HB1616:** Uniform Record-Keeping Requirements – Lillian Reese, Legislative Liaison, will inform the Board when the hearing on this Bill is scheduled. David Cox motioned to oppose HB1616; 2nd by Margaret Hayes. The motion passed. Board Vote: 7/0/0.

HB639: This Bill refers to Cultural Competency Coursework & Training. The Massage Board does not support this Bill.

CEU's-CPR Requirement for LMT vs. RMP – An inquiry was received requesting clarification on the CPR requirements for LMTs & RMP's. LMTs are required to be certified at the Healthcare Provider Level. RMPs are required to be certified at the basic level.

2019 Financial Disclosure Filing Due by April 30, 2020 – Board members were reminded of the filing deadline.

Security Concerns-Installing Security Doors – Reports of security issues affecting the Metro Center Building. There are plans to install security doors in strategic places throughout the 3<sup>rd</sup> floor.

#### **Committee Reports**

Advisory Committee –The Advisory Committee is reviewing CPR certification language in current regulations. The Board approved the committee's recommended changes to regulations, including grammatical/spelling changes submitted by Gwenda Harrison. The CPR regulations language remains unchanged. Board Vote: 7/0/0.

Licensing Committee – David Cox briefed the Board on a draft list of approved modalities/CE Courses and accepted college courses for Basic and Applied Science. Board Members are to review the list for discussion at a later time.

#### **CEU Requests for Approval:**

- o "Exercise Therapy" provided by International Sports Sciences Association (20 CEU Hours). The Licensing Committee recommended to deny this request since this CEU does not fall under the Massage Board Regulation scope of practice.
- "Marijuana & Cannabinoids: What Health Professionals Need to Know" provided by the Institute for Natural Resources (6 CEU Hours). The Licensing Committee recommended approving this course since it falls under the Massage Board's Regulation scope of practice.



Motion to accept the Licensing Committee's recommendations regarding the [2] CEU requests by Caitlin Thompson; 2<sup>nd</sup> by Kirsten Bodnarchuk. The motion passed. Board Vote: 7/0/0.
