

**Tentative Agenda**

**Policy Retreat, June 16, 2006**

The MCHRC is charged with awarding grants to organizations for the purpose of supporting access to primary care (and later specialty care) in Maryland. The Commissioners realize that the money they have available for this activity is, in relation to total health care costs, or the need, is small. If the Commission's grant making program is to succeed it will need to award its grants strategically and seek to maximize the benefit they can provide.

Toward that end, the purpose of the retreat is two fold.

- To provide the Commissioners with an overview of the health care landscape in Maryland, focusing on issues of access and uninsurance. In addition it will provide some general background on the role publicly funded programs play in providing (or not) financial access to low income populations in Maryland.
- To hear the thoughts of key policy makers in Maryland on what initiatives might provide the greatest benefit to improving access to care. It is assumed that Commissioners will be able to engage in discussion with these individuals to explore issues and opportunities. Also, since the format assumes discussion of policy issues and options the presenters should be senior enough to be able to comment on their organizations policy priorities.
