





Re: Adjustment to Fiscal Year 2012 Program Rates

On July 1, 2011, payment rates for certain services under the Waiver for Older Adults Program will decrease. Rates will decrease by 1 percent based on the Medical Assistance Program's budget for Fiscal Year 2012.

Attached is a list of revised payment rates for Fiscal Year 2012. Providers may bill the new rates for services provided on or after July 1, 2011.
