RE:

Reimbursement for Comprehensive Substance Abuse Assessment (CSAA)

The purpose of this transmittal is to describe the two options under which a provider can receive payment for administering a comprehensive substance abuse assessment and placement (CSAA), as defined by HealthChoice regulations.

# Definition of a Comprehensive Substance Abuse Assessment (CSAA)

As defined by COMAR 10.09.65.11, the CSAA includes the application of the following instruments, as appropriate:

- Addiction Severity Index (ASI) for enrollees aged 20 or older. 0
- Problem Oriented Screening Instrument for Teenagers (POSIT) for enrollees 0 under age 20.

o American Society of Addictions Medicine Patient Placement Criteria for the Treatment of Substance-Related Disorders, 2nd Ed. (ASAM PPC-2) to determine appropriate level and intensity of care.

### MCO Enrollee - Self-Referral Option

The purpose of this option is to remove barriers for MCO enrollees who directly seek substance abuse treatment services. (Please note that nothing in this initiative diminishes the MCO's responsibility or authority to manage the enrollee's substance abuse treatment.) Under this option, the MCO is responsible for paying for the CSAA only if the following conditions are met:

The recipient is not in substance abuse treatment;

The recipient has not received a self-referred CSAA that calendar year; and

The assessment provider is an ADAA-certified substance abuse provider who is qualified to administer the ASI or POSIT, and the ASAM.

The CSAA provider must send the results of the assessment to the MCO, so the MCO does not duplicate the assessment and can determine to which provider to refer the client. If the substance abuse treatment provider who did the assessment wants to treat this client, it must negotiate with the MCO to retain the client. Each MCO determines conditions for provider participation, reimbursement amount, and payment process. This process is represented in Attachment I.

The MCO will reimburse any ADAA-certified provider at a rate of \$50.00 for a CSAA which meets the conditions described above. Providers are advised to determine whether or not an MCO member is currently in treatment, or has had a self-referral visit during the current calendar year by calling the appropriate contact number of the enrollee's MCO. If these conditions are met, the provider can bill the MCO using procedure code W3901. See Attachment II for the numbers to call to determine whether the MCO is required to pay for a CSAA for the recipient and to obtain instructions for billing the MCO. Please note that a provider does not have to be a Medicaid enrolled provider to bill the MCO for this service.

## Fee-for-Service Medicaid Recipient Option

A Medicaid recipient who is not enrolled in an MCO (fee-for-service recipient), may receive a CSAA by any certified ADAA provider that is enrolled as a Medical Assistance provider. The provider will be reimbursed by the Medical Assistance Program at a rate of \$50.00 for the CSAA. The provider must bill on a HCFA 1500 form using procedure code W3901.

### Referral to Qualified CSAA Providers

If an MCO enrollee or a fee-for-service recipient goes to an ADAA-certified provider who is <u>not qualified</u> to administer the CSAA using the prescribed tools, that provider should refer the individual to an ADAA-certified provider which is qualified to administer a CSAA using the prescribed tools. Attachment III lists ADAA-certified and -funded providers, all of which are qualified to administer the ASI, POSIT, and ASAM.

However, some of these providers might not be enrolled as a Medical Assistance provider of the ASI or ASAM. If the Medicaid enrollee requiring a CSAA is an MCO member, the CSAA provider does not have to be a Medicaid provider. If the enrollee is not an MCO member (fee-for-service), the provider must be a Medicaid provider. Please contact the provider prior to referral to determine their enrollment status with Medical Assistance.

Local Department of Social Services (LDSS) workers may continue to refer applicants to ADAA-funded providers, which may serve these applicants with grant funds since they have not yet been found eligible for Medical Assistance. This is current practice, and does not affect, nor is it affected by, the self-referral initiative.

# SELF-REFERRAL BY TCA RECIPIENT WHO IS ENROLLED IN AN MCO

### TCA Recipient

Requests Substance Abuse Treatment from an ADAA-certified provider.

### ADAA-Certified Substance Abuse Treatment Provider

- Administers ASI or POSIT and ASAM if appropriate.
- ·Notifies recipient's MCO of results.
- · If MCO authorizes continued treatment, provider is responsible for filing DHR/FIA #1178 form.

### MCO

- · Authorizes treatment
- Arranges for transfer of recipient to an appropriate substance abuse treatment provider in its network.
- Pays for assessment but is not responsible for other services it did not authorize.
- MCO is only responsible for one self-referred assessment per calendar year.
