#### **Coordinating Services**

- It's the responsibility of the supports planner to identify what other programs the person is in and coordinate services.
- Important because:
  - Certain services may not overlap.
  - The person may have other case managers, or coordinators of community services.
  - The person may have other applications submitted.
- Check for any active special program codes from the Client Summary in LTSS
  - Supports Planner should upload the service plan from any other program enrollment and include a task schedule that displays clearly when each service will be provided, by which program



## Other Programs with Similar Target Populations

- Medical Day Care Waiver
- DMS/DME
- Community Pathways
- Rare and Expensive Case Management (REM)
- Model Waiver
- Autism Waiver
- Medicare
- Nursing Facility Services



#### Guidelines for Program Enrollment

- A participant may only be enrolled in one waiver at a time.
- CFC and CPAS are not waivers and may overlap with a waiver span, or other State Plan service (e.g., REM, Health Homes).
- Long Term Care MA may not overlap with any community program.



#### Medical Day Care

- A person may attend a day care center during the day instead of staying at home, or in their assisted living facility.
  - Day care centers provide a bundled package of services (including a meal).
  - No other services may be paid for while the person is at the day care center.
  - A person may receive personal assistance before, or after, attending the center.



#### Medical Day Care: CO Waiver vs. CFC

- If the person is on the <u>CO Waiver</u>, the person may receive services at a day care center in the following manner:
  - Add Medical Day Care Service on the Plan of Service and select the appropriate day care center.
  - Bring the Plan of Service to the center and have them signoff that they will in fact allow the person to participate.
  - Have the Plan of Service approved.
  - Schedule the first day of service at the center.
- A person in an assisted living may attend a center.
  - Discuss with the assisted living how to coordinate this service.



#### Medical Day Care: CO Waiver vs. CFC

- If the person is in the <u>CFC program</u>, the person may receive services at a day care center in the following manner:
  - Request Medical Day Care information from the Local Health Department.
    - LHD will update recommended plan of care and approval notice for Medical Day Care.
    - LHD will send an email to the supports planner/applicant when this is complete.
  - Bring this information to the center and request to be placed on the Medical Day Care Waiver.
    - There is an application process to be completed.
  - Once the person is approved for the waiver, add Medical Day Care Waiver services to the Plan of Service and schedule the first day of service at the center.



#### DMS/DME

- DMS/DME Regulations can be found in COMAR 10.09.12
- DMS/DME requests must be submitted to the appropriate office at the Department.
  - Items may require a pre authorization form (MDH-4527)
  - If an item is rejected by the DMS/DME unit, it will not be approved on the plan of service.

#### **Community Pathways**

- Designed for people with intellectual disabilities (no age limit).
- Services are similar to those in the waiver, and populations may receive both Community Pathways and Community First Choice.
  - Supports Planner should speak with the participant's "coordinator of community services" to discuss the participant's "individual plan" for Community Pathways.
  - Services must be coordinated and not overlap (claims will not pay in certain instances).



### Rare and Expensive Case Management (REM) and Model Waiver for Children

- REM participants have higher case management needs.
- REM participants have a case manager for the REM program specifically.
  - All REM case managers are under contract with The Coordinating Center.
- Private Duty Nursing is a limited benefit under these programs.
  - Children under EPSDT (Early and Periodic Screening Diagnostic and Treatment) may also receive Private Duty Nursing.



#### Waiver for Autism Spectrum Disorder

- The program provides services targeted for children with an Autism diagnosis.
- Services are similar to those offered under the CFC and CO programs.
  - Residential services
  - Day habilitation and school-based services
  - Family consultation
  - Environmental accessibility adaptations
  - Respite care



#### Medicare

- Medicare is the federal companion to Medicaid
- A participant in Medicare and Medicaid is called a "dual-eligible."
- Explore Medicare benefits and how they coincide with Medicaid.



#### **Nursing Facilities**

- The State has over 200 nursing facilities.
- The participants in our programs have chosen the community over an institutional setting like a nursing facility.
- No services may be billed while the participant is residing in the nursing facility
  - With the exception of certain supports planning services.
