ORDER LIFTING SUSPENSION

On or about September 28, 2020, Nesheka Jessup submitted a petition to the Maryland Board of Pharmacy (the "Board") requesting that the Board lift the suspension of her license, License No. 18182, initially set forth in a Consent Order in Lieu of Summary Suspension dated January 15, 2019. The Consent Order in Lieu of Summary Suspension provided that Ms. Jessup's license would remain suspended until the North Carolina Board of Pharmacy reinstated her license to practice pharmacy in North Carolina and ordered that she fully comply with her agreement with the North Carolina Professionals Health Program during the suspension period. Along with her petition to lift the suspension of her license, Ms. Jessup submitted proof that her license to practice in North Carolina was reinstated on November 19, 2019. On or about October 26, 2020, the Board received a letter indicating that Ms. Jessup was fully in compliance with her agreement with the North Carolina Professionals Health Program. Upon review of the information submitted by Ms. Jessup, the Board voted to lift the suspension and place Ms. Jessup on immediate probation with terms as set forth below.

ORDER

It is this 23rd day of February, 2021, by an affirmative vote of the Maryland Board of Pharmacy, hereby:

ORDERED that the suspension of Ms. Jessup's license be lifted; and be it further,

ORDERED that Ms. Jessup's license be placed on immediate PROBATION for FIVE (5)

YEARS, effective April 5, 2019, during which she shall:

1. Comply with the terms of her Consent Order with the North Carolina Board of Pharmacy;
2. Comply with and complete the terms of her agreement with the North Carolina Professionals Health Program; and
3. Notify the Board within five (5) business days of any modifications to her Consent Order with the North Carolina Board of Pharmacy; and be it further,

ORDERED that upon completion and termination of her agreement with the North Carolina Professionals Health Program, Ms. Jessup may petition the Board for early termination of probation, provided that she has been fully compliant with the terms of probation and does not have any pending complaints filed against her; and be it further,

ORDERED that after five (5) years of probation, Ms. Jessup may petition the Board to terminate probation, provided that she has been fully compliant with the terms of probation and does not have any pending complaints filed against her; and be it further,

ORDERED that Ms. Jessup shall at all times cooperate with the Board in the investigation of her compliance with the terms and conditions of this Order; and be it further,

ORDERED that Ms. Jessup's failure to fully cooperate with the Board shall be deemed a violation of the probationary terms and a violation of this Order; and be it further,


ORDERED that in the event the Board finds in good faith that Ms. Jessup has violated any of the conditions of probation herein, the Board may take further disciplinary action against Ms. Jessup's license after notice and the opportunity for hearing; and be it further,

ORDERED that Ms. Jessup shall bear the expenses associated with this Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Pharmacy and as such is a public document pursuant to Maryland Code Ann., General Provisions § 4-333(b).
