**ORDER FOR SUMMARY SUSPENSION**

Pursuant to Md. State Govt. Code Ann. §10-226 (c) (2)(2009 Repl. Vol.), the State Board of Pharmacy (the "Board") hereby suspends the license to practice as a Pharmacy Technician in Maryland issued to Shiloh Pilito, Pharmacy Technician (Pharm Tech), (the "Respondent"), under the Maryland Pharmacy Act (the "Act"), Md. Health Occ. Code Ann. § 12-101, et seq., (2009 Repl. Vol.). This Order is based on the following investigative findings, which the Board has reason to believe are true:

**BACKGROUND**

1. At all times relevant hereto, the Respondent was registered to practice as a Pharm Tech in Maryland. The Respondent was first registered on October 29, 2008. The Respondent's registration expired on February 28, 2010.
2. At all times relevant hereto, the Respondent was employed as a Pharm Tech at Manchester Drugs, Inc. in Taneytown, Maryland.
3. From 2007 through 2009, the Respondent stole drugs from her employer. On December 11, 2009, the Respondent was caught on tape stealing narcotics. Thereupon, she was terminated and confessed to stealing.<sup>1</sup>

<sup>1</sup>The Respondent was criminally charged with theft, less than \$1000, and awaits trial.

### **FINDINGS OF FACT**

As set forth above, by stealing narcotics from her employer, the Respondent is a threat to the public health, welfare or safety.

### **CONCLUSIONS OF LAW**

Based on the foregoing, the Board finds that the public health, safety or welfare imperatively requires emergency action, pursuant to Md. St. Gov't. Code Ann. §10-226(c) (2) (2009 Repl. Vol.).

### **ORDER**


Based on the foregoing, it is therefore this 23<sup>rd</sup> day of **June**, 2010, by a majority vote of a quorum of the State Board of Pharmacy, by authority granted by the Board by Md. St. Gov't. Code Ann. § 10-226(c)(2) (2010 Repl. Vol.), the license held by the Respondent to practice as a Pharm Tech in Maryland, Registration No. T03308, is hereby **SUMMARILY SUSPENDED**; and be it further

**ORDERED**, that upon the Board's receipt of a written request from the Respondent, a Show Cause Hearing shall be scheduled within a reasonable time of said request, at which the Respondent will be given an opportunity to be heard as to whether the Summary Suspension should be continued, regarding the Respondent's fitness to practice as a Pharm Tech and the danger to the public; and be it further

**ORDERED**, that the Respondent shall immediately turn over to the Board her wall certificate and wallet-sized registration to practice as a Pharm Tech issued by the Board;

and be it further

**ORDERED**, that this document constitutes a final Order of the Board and is therefore a public document for purposes of public disclosure, as required by Md. State Gov't Code Ann. §10-617(h) (2009 Repl. Vol.).
