ORDER LIFTING SUSPENSION

On June 12, 2018, the Maryland Board of Pharmacy (the “Board”) issued an Order of Suspension of Registration for Delinquent Child Support (“Order of Suspension”) against Eddie Williams III, Pharmacy Technician, Registration No. T20121 (the “Respondent”). The Board suspended the Respondent’s registration to practice as a pharmacy technician in Maryland due to allegations of his delinquent child support payments upon a request from the Harford County Office of the Child Support Enforcement Administration of the Maryland Department of Human Resources (the “Administration”), pursuant to Md. Code Ann., Fam. Law § 10-119.3(e)(2)(i) (2012 Repl. Vol.).

On July 25, 2018, the Board received information from the Administration indicating that the Respondent’s registration should no longer be suspended for delinquent child support payments. Pursuant to the Maryland Pharmacy Act, Maryland Code Ann., Health Occ. §§ 12-101 *et seq.*, the Respondent otherwise qualifies for a registration.

Therefore, pursuant to Md. Code Ann., Fam. Law § 10-119.3(k), on this 26th day of July, 2018, by the Maryland Board of Pharmacy, it is hereby:

ORDERED that the suspension of the registration to practice as a pharmacy technician in Maryland held by Eddie Williams III, Registration No. T20121, is **LIFTED**; and it is further,

ORDERED that the registration to practice as a pharmacy technician in Maryland held by Eddie Williams III, Registration No. T20121, is **REINSTATED**; and it is further,

ORDERED that this is a Final Order of the Maryland Board of Pharmacy and, as such, is a public document pursuant to Md. Code Ann., Gen. Provisions §4-333(b).
