2. To invite public comment on these regulations, the following procedures and methods are used:
    - a. Publication of notice in the Maryland Register; and
    - b. To ensure the participation of stakeholders in the review process, the Commission presents the regulation in draft form to the public for a ten day comment period, prior to the regulation going to the Commission for proposed action.
    - c. To ensure the participation in the review process of other units affected by the regulations, the Commission holds public meetings at the time the Commission takes proposed action on the regulations and they are cleared for ABLR review, followed by publication in the Maryland Register for a thirty-day comment period.
  
  3. For those regulations determined to be necessary, an evaluation based on adequacy and appropriateness will be initiated based on:
    - a. Clarity and comprehensibility;
    - b. Consistency with federal regulations and other state regulations;
    - c. Effectiveness in accomplishing the intended purpose of the regulations;
    - d. Review of relevant statutes.
  
  4. Evaluate to determine whether these regulations could be condensed or consolidated to eliminate duplication and achieve simplicity
    - a. The dates that the set of regulations reviewed was originally adopted or last amended;
    - b. A summary of any proposed amendments to the unit's regulations;
    - c. A summary of any proposed repeal of those regulations;
    - d. Any proposed reorganization of those regulations.
