GENERAL RULES FOR OPEN BURNING

1. A permit must be secured for each operation, except as provided in Comar 26.11.07.
2. No nuisance may be created. THE BURN MUST BE AT A MINIMUM 200' FROM ANY HABITABLE DWELLING, AND/OR ROADWAY.
3. Provision must be made for proper ventilation of the burning material to avoid excess smoke and to promote rapid and complete combustion.
4. rapid and complete combustion.
5. No tires, heavy oil or other smoke-producing fuel may be used to start fires.
6. Burning is limited to only those materials generated on site.
7. Asbestos materials, plastics, tar paper, vinyl siding, and asphalt shingles are prohibited from burning.

I have read the above noted rules for open burning and agree to comply with the "CODE OF MARYLAND REGULATIONS" 26.11.07, pertaining to air quality and the general rules stated above. I will comply with all local, county and state laws and regulations while burning. I will notify the Fire Control Center, (410) 822-0095 before burning.

The applicant is hereby notified that should the burn be for forestry or agricultural operations, or within two hundred (200) feet of woodland or flammable material that could ignite and carry fire to woodland, approval must be obtained from the Forest Ranger, Department of Natural Resources, Forest, Park & Wildlife Service at (410) 479-1623. The burn must comply with Regulation 08.07.04.
