Welcome, Introductions, and Review of Agenda

Meeting was called to order at 5:15pm by RHC President Fredia Wadley, MD. Dr. Wadley thanked everyone for attending, welcomed everyone to the meeting, and reviewed the agenda for the meeting.

Discuss Results of County Meetings

Ron Bialek, MPP, RHC Executive Director

RHC Executive Director Ron Bialek, MPP, provided a summary of the results of meetings held in each county with the county's Health Department, Department of Social Services, Area Agency on Aging, and

other partners. These meetings occurred in August 2019 and were held at the request of the RHC's Integrating Clinical and Social Support Services Workgroup to learn more about how clinical and social services are coordinated in each county for the Medicare population. Meeting topics included roles, leadership engagement, identifying and addressing needs, partnerships, successes, challenges, and future opportunities. What was learned from these meeting in relation to agency staffing, community resources, coordination and integration, identifying needs, Adult Evaluation and Review Services (AERS), transportation, partnerships, successes, and commitment and creativity was summarized. Presentation slides are attached.

RHC members shared their reactions to the meeting summaries. RHC members discussed informal networks, awareness of resources available, the Village model, connections between clinical and social services, education and training, community health workers, mobile integrated health, need for data, engaging IT expertise, emergency management, and care transformation organizations (CTOs).

Steps to Advancing the Rural Health Model and Rural Health Complex

An opportunity to meet with CTOs serving the Mid-Shore Region was discussed. Dr. Wadley and Dr. Ciotola will meet with the CTOs to learn more about needs. Dr. Ciotola may form a workgroup with other RHC members to explore connections with CTOs.

Dr. Wadley will work with a workgroup on drafting components and standards for a rural health complex.

Nominations for Rural Health Collaborative Members

The RHC has three vacant seats that need to be filled: a primary care provider who practices in the Mid-Shore Region, health care provider from Dorchester County, and primary transportation provider in the Mid-Shore Region. In addition, terms will end on January 31, 2020 for four current RHC members: those representing a health care provider from Caroline County, health care consumer from Dorchester County, health care consumer from Kent County, and local Board of Education in the Mid-Shore Region. RHC members whose terms are ending are eligible for an additional term. RHC members offered nominations for individuals to fill these seats. A reminder requesting nominations will be sent by email. Nominations will be compiled and presented to the RHC Executive Committee for consideration.
