## 1. CALL TO ORDER AND ESTABLISHMENT OF A QUORUM

Mr. Kaufman called the Acupuncture Board meeting to order at 1:00 pm and a quorum was established. Mr. Kaufman welcomed guests and asked that they introduce themselves.

Mr. Kaufman welcomed our newest Board member, Deneb Falabella and asked her to present a brief background.

#### 2. APPROVAL OF MAY 11, 2010 MINUTES

After review of the Minutes, Ms. Carter moved to approve the Minutes and Mr. Zhang seconded the motion. The motion passed unanimously.

# 3. OLD BUSINESS

#### A. FAOMRA

Ms. Heisler informed the Board that the FAOMRA Board of Directors assessed the continued need for the organization and voted to fold. Over the past 3 years, FAOMRA meetings have continuingly been canceled due to non-interest or lack of funds. The Board has sought advice of attorneys to assist in folding the organization.

#### 4. NEW BUSINESS

#### A. NEW LICENSES

Mr. Zhang moved to approve the list of applicants for licensure and Ms. Axelrod seconded the motion. The motion passed unanimously.

#### **B.** 2010 BUDGET

Ms. Heisler updated the Board on the revenue and expenditures of FY 2010.

# C. CEU REQUIREMENTS

#### **YOGA**

Ms. Heisler received a request from a licensee inquiring whether yoga taught at a gym would be acceptable for CEU's. After a lengthy discussion it was determined that a course in Yoga, whether taught in a school or a gym, would not be acceptable for CEU's.

#### REINSTATEMENT

Ms. Heisler asked the Board if they would be willing to put a cap on the number of CEU's needed for reinstatement. Currently, the Board's requirements for reinstatement are 40 hours for every two years a licensee was not practicing in the State of Maryland. After discussion, Mr. Kaufman called to form a CEU committee. Ms. Falabella, Ms. Axelrod and Ms. Carter volunteered to serve on the committee with Ms. Heisler and Mr. Bloom.

## **SANCTIONING GUIDELINES**
