CALL TO ORDER AND ESTABLISHMENT OF A QUORUM

APPROVAL OF MAY 9, 2017 MINUTES

After review of the Minutes, Mr. Exler moved to approve the Minutes as written and Ms. Beatty seconded the motion. The Board unanimously approved the motion.

1. OLD BUSINESS

A. SCOPE OF PRACTICE

Mr. Ingegno informed the Board that there is no report at this time.

B. LIGHT THERAPY

Mr. Ingegno stated that Andrew Bloch, L.Ac., had submitted a question to the Board via email, regarding whether a properly trained Maryland licensed acupuncturist could administer light therapy through a hollow needle using Chinese medicine philosophy. The Board invited Mr. Bloch to the meeting for questions and answers. Mr. Block gave a brief overview of his

education and explained basic light therapy techniques. He stated that the technique involves the administration of different lights (blue, green, yellow and red) through a hollow needle, either in a point or intravenously, which causes a photodynamic reaction within the body to regulate Qi and blood. After a lengthy discussion, Peter Marinakis moved to send the issue to the Scope of Practice Committee for further review and send a written response to Mr. Bloch within one month and Jan Exler seconded the motion. Mr. Ingegno restated the motion and opened it up for debate. After a lengthy discussion, Jan Exler moved to direct Ms. Heisler to write a letter to Mr. Bloch stating that the Board, at this time, does not consider the use of a hollow needle intravenously to be within the scope of the Maryland Acupuncture Practice Act. Teal Beatty seconded the motion. The motion was approved by Teal Beatty, Sheryl Hongsermeier, Peter Marinakis, Jan Exler and Barbara Heller. Mr. Ingegno abstained. Mr. Finkler advised the Board to include a disclaimer.

C. LEGISLATION 2018

Ms. Heisler reported that at the last meeting, the Board voted to submit a pre-proposal concept paper to DHMH to propose changes to its statute to include Oriental medicine in its scope, repeal foreign equivalency review, and revise the number of hours of training to reflect current standards. She stated that the Department had approved the concept paper. A copy of the draft Bill was provided to the Board and a courtesy copy was sent to the Maryland Acupuncture Society (MAS). Ms. Heisler stated that David Blaiwas, President of MAS, had informed her that the Association will not support the Bill. Mr. Blaiwas informed the Board that although MAS supports the content of the Bill, the Association is concerned about the current political environment and opening the Board's statute at this time.

Mr. Exler moved to pull the bill and Barbara Heller seconded the motion. The Board unanimously approved the motion.

3. NEW BUSINESS

Mr. Ingegno tabled the discussion until the next meeting.
