ORDER OF REINSTATEMENT

WHEREAS, on October 18, 2016, the Maryland State Board of Professional Counselors and Therapists (the "Board") accepted from Judy Strouse, License Number SC0127, a Public Surrender of her Certified Supervised Counselor – Alcohol and Drug ("CSC-AD") Certificate to practice alcohol and drug counseling in the State of Maryland;

WHEREAS, on July 11, 2018, the Board having received an application for reinstatement,

WHEREAS, the Board hereby approves Judy Strouse's petition for reinstatement pursuant to the Health Occupations Article ("HO") section 17-514. It is therefore:

ORDERED, that effective October 2, 2018, Judy Strouse's license shall be **REINSTATED with conditions**; and it is further

ORDERED that Judy Strouse shall comply with the terms and conditions as set forth herein:

1. Judy Strouse shall be on **PROBATION** for a period of **two years**.
2. Judy Strouse must disclose the conditions of her reinstatement to her employer and her supervisor.
3. Judy Strouse's supervisor shall notify the Board in writing of his/her acceptance of the supervisory role of Judy Strouse.
 - (a) The supervision shall continue for the entire two-year probationary period;
 - (b) The supervision must include discussion about dual relationships and maintaining boundaries with clients;
 - (c) The supervisor shall meet with Judy Strouse and submit quarterly reports to the Board; and

- (d) Judy Strouse is solely responsible for ensuring that her supervisor submits the required quarterly reports; and it is further

ORDERED, that if Judy Strouse fails to comply with the aforementioned terms and conditions, the Board may, after notice of the alleged noncompliance and a hearing, and a determination of a violation, impose any disciplinary sanction it deems appropriate under HO § 17-509; and it is further

ORDERED, that Judy Strouse shall petition the Board for full reinstatement of her Maryland CSC-AD license, provided that, at that time, Ms. Strouse has fully satisfied the conditions stated herein, is not under investigation, or no charges have been issued against her; and it is further

ORDERED, that this a Final Order of the Maryland State Board of Professional Counselors and Therapists and as such is a **PUBLIC DOCUMENT** pursuant to Md. Code Ann., State Gov't Art., §§ 10-611, *et seq.*

Dear Dr. Deel and Members of the Board:

I have decided to **SURRENDER** my certificate to practice as a Certified Supervised Counselor - Alcohol and Drug ("CSC-AD"), in the State of Maryland, License Number SC0127, effective immediately.¹ I understand that upon the Board's acceptance of this letter of surrender of my certificate, I may not represent myself to the public by title, by description of services, methods or procedures, or otherwise that I am a CSC-AD. Moreover, I may not engage in the practice of alcohol and drug counseling in the State of Maryland, with or without supervision and/or compensation, as it is defined in the Maryland State Board of Professional Counselors and Therapists Act (the "Act"), Md. Code Ann., Health Occ. ("Health Occ."), §§ 17-101 *et seq.*, (2014 Repl. Vol.) and other applicable laws. In other words, as of the effective date of this Letter of Surrender, I understand that the surrender of my certificate means that I am in the same position as an uncertified or unlicensed individual in the State of Maryland.

I understand that this Letter of Surrender is a **PUBLIC DOCUMENT** and on the Maryland State Board of Professional Counselors and Therapists' (the "Board's") acceptance becomes a **FINAL ORDER** of the Board.

My decision to surrender my certificate to practice as a CSC-AD in the State of Maryland has been prompted by the Board's investigation and charges that I engaged in a sexual relationship with a former alcohol and drug client who had been in one of my therapy groups for intensive outpatient therapy for approximately three months. My

¹ I allowed my certificate to expire on January 31, 2016; however, pursuant to Md. Code Ann., Health Occ. § 17-508, for purposes of discipline, since the Board initiated its investigation prior to the expiration of my certificate, while charges are pending, a regulated counselor or therapist may not allow the certificate to lapse by operation of law.

personal relationship with the client began two months after our client therapist relationship ended, and took place over the course of approximately five months.

I wish to make it clear that I have voluntarily, knowingly, and freely chosen to submit this Letter of Surrender in lieu of the Board proceeding with prosecution of the disciplinary charges.

If the case were to proceed to a hearing, the Board would submit evidence to prove the investigatory findings that I violated the following provisions under the Act: Health Occ. § 17-509(8) (violates the code of ethics adopted by the Board); (9) (knowingly violates any provision of this title); (13) (violates any rule or regulation adopted by the Board); (16) (commits an act of immoral or unprofessional conduct in the practice of clinical or nonclinical counseling or therapy); and the following regulations of the Board: Md. Code Regs. 10.58.03.04A(1), (11) and (14); 10.58.03.04B(3); 10.58.03.05A(2)(a), 10.58.03.05B(1)(a) and (b); and 10.58.03.09A(1) and (4); and 10.58.03.09C(1) and (2); and that for purposes related to certification as a CSC-AD, the investigatory findings will be treated as if proven. I understand that by executing this letter of surrender, I am waiving any right to contest the charges that the Board issued in this case.

I understand that the Board will advise the Federation of State Counseling Boards and the National Practitioners' Data Bank of this Letter of Surrender, and in any response to any inquiry, that I have surrendered my certificate in lieu of disciplinary action under the Act as resolution of the matters pending against me. I also understand that in the event I apply for a certificate in any form in any other state or jurisdiction, this Letter of Surrender and the underlying investigative documents may be released or published by the Board to the same extent as a final order that would result from disciplinary action, pursuant to Md. Code Ann., Gen. Prov. §§ 4-101-4-601 (2014), and that this Letter of Surrender is considered a disciplinary action by the Board.

I affirm that on or before the date of the Board's acceptance of this Letter of Surrender, I will provide to Board staff a copy of my initial CSC-AD certification, any renewal certificates and my most recent renewal certification issued by the Board.

I further recognize and agree that by submitting this Letter of Surrender, my certificate will remain surrendered unless and until I petition the Board for reinstatement; and I understand that when applying for reinstatement, I approach the Board in the same posture as one whose certificate has been revoked based on the investigative findings contained herein and that my petition may be accepted or denied by the Board in its sole discretion.

I understand that if the Board reinstates my certificate to practice as a CSC-AD, the Board may set additional terms and conditions that shall apply to my reinstated or new certificate, which may include the imposition of probation.
