For the time being I have decided to surrender my program administrator's certificate. I understand that upon surrender of my certificate, I may not practice as a program administrator in this State. I wish to make it clear that I have voluntarily, knowingly and freely chosen to submit this Letter of Surrender and that I am not however barred from making application to the Board to reinstate my certificate in the future. My decision to surrender my certificate is prompted by the fact that I am no longer acting in the capacity of a residential child care program administrator and to date have not completed the required continuing education requirement needed to maintain certification. I fully acknowledge that my certificate was renewed on March 19, 2010 with the understanding that I would complete the requirement within a reasonable period of time.

I also understand that in the event I would apply for certification in any form in any other state or jurisdiction, that this Letter of Surrender, and all underlying documents, may be released or published by the Board, pursuant to Md. State Gov't Code Ann §§10-611 et seq. (2009).




