Call to Order at 10:03 a.m. & Opening Remarks by Board Chair

The regularly scheduled Open Session meeting of the Maryland State Board of Massage Therapy Examiners was held via teleconference call on October 28, 2020. The meeting was called to order at 10:03 a.m. by Board Chair Caitlin M. Thompson, LMT. Roll call was taken and all Board Members were present. Caitlin M. Thompson expressed her gratitude as the newly elected Board Chair and stated that her mission is to be equitable, reasonable and fair while expanding the scope of practice for the Massage Board.

Parliamentarian- Kirsten Bodnarchuk volunteered to become Board Parliamentarian. The Open Meetings Act Training is a requirement to become Parliamentarian.

BOARD COUNSEL

Grant Gerber welcomed Caitlin Thompson as the new board chair. Grant Gerber will discuss regulations in the administrative session. Due to preparation for the upcoming Legislative session there will be a "blackout period." Therefore Regulation Committee Meetings will be suspended. Grant stated that he will be available to assist and support the review of regulations.

EXECUTIVE DIRECTOR'S REPORT

Renewals Update - Sharon Oliver welcomed Eric Newdom to the Board Meeting. We are currently at a 51.2% completion rate with \$527,698 in revenue. The Board has been receiving numerous calls regarding the renewal expiration date. Renewals completed past the October 31st deadline will not be assessed a late fee due to the current State of Emergency.

Question from Out of State Licensee- The Board received a call from a licensed massage therapist in Arizona with 35 years of experience as a massage professional. The inquiry was regarding whether or not the individual would have to take the National exam. The LRC will respond to these inquiries.

2021 Legislative Bill Sponsor- Amelia Mitchell, Board Member, AMTA discussed the progress of the Massage Bill. Currently the Bill is in the drafting phase. The purpose is to clarify and update the language to reduce ambiguity.

Caitlin Thompson acknowledged the Board Staff for their hard work and efforts during the renewal time. The license renewal date for the 2020 cycle will expire 30 days after the State of Emergency is lifted.

COMMITTEE REPORTS

Advisory Committee

Telehealth Regulations – Paula Jilanis explained the scope of practice language & discussed remote performance. Paula Jilanis also discussed changes in the language. The recommendation of the Advisory Committee is to accept the Telehealth Regulations as written. All in favor to accept the recommendations from the Advisory Committee.

Licensing Committee (LRC)

Potomac Massage Training Institute's (PMTI) proposed program modification received – Kirsten Bodnarchuk announced that a letter was received from MHEC stating there were no significant changes. Changes based on when next semester of classes will begin. The LRC will send a reminder letter to schools to inform the Board when a school has been approved.

Miscellaneous

Questions Submitted by the Public on behalf of AMTA Submission - (Caitlin Thompson)

"With the State of Emergency allowing people to delay their renewal, are licensees still allowed to continue taking CEU courses for 2020 renewal until the State of Emergency is lifted plus the 30 day grace period?"

Yes, you may continue to take CEU Coursework to satisfy the requirements until the State of Emergency is lifted. Technically renewals are not due October 31, 2020.

"If someone has already renewed as of November 1, 2020, can they begin taking CEU Credits that will counts towards the 2022 renewal cycle?"

Yes, you may take CEU Credit Coursework that will count towards the next renewal cycle.

"What about those who have not renewed due to the Governor's State of Emergency Order? Will there be a distinction by date for CEU credits as earned before or after renewal? How will the Board make this distinction?"

The Board will work with the IT department to review the CEU completion date and compare the renewal date as it appears in the renewal portal. If there are any discrepancies or falsifying of information, the individual will be flagged for an audit.

"Knowing that most people plan ahead to complete their CEU's AMTA respectfully requests the Board to address the concern surrounding carryover CEU's into the 2022 renewal cycle".

Given the 17 CEU Credit waiver- if a licensee has completed the entire 24 CEU coursework, they will receive credit for the next 2022 cycle. Motion to allow the carryover of 17 CEU's completed prior to the waiver requirement from the 2020 renewal cycle to be used in the 2022 renewal cycle by LMT's & RMP's by Paula Jilanis; 2nd by David Cox. The motion passed. Board Vote: 7/0/0. Board Discussion.

(Amended) Motion to allow the carryover of up to 17 CEU's completed prior to the waiver requirement from the 2020 renewal cycle to be carried over to the 2022 renewal cycle by Paula Jilanis; 2nd by David Cox. The motion passed. Board Vote: 7/0/0.

"What will happen if we are still in a State of Emergency by the start of the 2022 renewal cycle?"

Unfourtunately, the Board is not in a position to answer this question at this time as it is premature. This question will be addressed at a later time.

Diane Jones Richards volunteered to join the Rehabilitation Committee.
