## <u>May 9, 2013</u> Room 100

## A. MINUTES:

## 1. MHCC Fees

## 2. Inquiry- Krista Lechliter

The Board received an inquiry from Krista Lechliter regarding employment at a podiatrist's office as a certified nail technician performing diabetic nail care and debriding calluses. The Board's response was that there is no certification she can receive, therefore, she can not work independently performing these tasks but she may work in a podiatrist's office under a licensed podiatrist's supervision.

The Board reviewed and approved the issuance of a Full license for the above applicants.
