ELECTION OF BOARD OFFICERS

The elections for all Board Officer Positions were held. After a vote, the Board welcomed the newly elected officers; Philip Cohen, D.P.M. President, Yvonne Umezurike, D.P.M. Vice President and Sharon Bunch, Secretary/Treasurer. Newly elected Board President, Dr Philip Cohen, continued the Open meeting.

A. MINUTES:

1. Approval of minutes from the July 12, 2018 meeting

The minutes from the July 12, 2018 meeting were approved unanimously, as submitted.

B. OLD BUSINESS:

1. HB 1452-Addressing CME Requirements concerning the issuance of a CDS permit and a Dispensing Permit for prescribing and dispensing opioids

The Board reviewed HB 1452 - Controlled Dangerous Substances Registration- Authorized Providers-Continuing Education. The Bill requires that all CDS permit holders or those applying for a new/initial permit, will be mandated to submit attestation to Maryland Department of Health (MDH)/Office of

Controlled Substance Administration (OCSA) regarding the completion of 2 CME credits before initial issuance of permit and at permit renewal, specific to prescribing and or dispensing scheduled drugs. The bill also indicates that failure to do so can lead to ineligibility for renewal of the CDS permit/registration by the Office of Controlled Substance Administration. The Bill will go into effect on October 1, 2018. To help inform new incoming licensees that attestation of 2 CME credits to OCSA will be required to receive a CDS permit during their application process, the Board has added the new law requirements to its website and the initial application for a Maryland License. The Board also informed all current licensees of the new 2 CME credit requirement prior to the renewal of their CDS permit via email. The Board discussed how current podiatrists may also use the required CME's by OCSA as part of their 50 CME's required to the Board during their full license renewals as long as they fall within the same cycle. The Board will not be promulgating regulations concerning the new OCSA CME requirement.

The Board received a copy of the Bulletin from the MDH Office of Inspector General (OIG) regarding ethics and conflicts for informational purposes.
