**Solicitation:** Independent Reviewer, Maryland Community Health Resources Commission (CHRC) Call for Proposals – **Essential health services: primary/preventative; women’s health; dental**

**Overview:** The Maryland Community Health Resources Commission (CHRC) released its FY 2018 Call for Proposals, “*Promoting Community Health Resources: Supporting innovative and sustainable projects that serve vulnerable populations and promote health equity,*” on October 19, 2017. The proposals are due to the CHRC on December 18, 2017, and grant awards will be made by the CHRC in February 2018.

Grants will be awarded by the CHRC on a competitive basis and will be evaluated on six review criteria established by the Commission (criteria are listed on pages 12-14 of the Call for Proposals). **The CHRC is seeking to hire an independent reviewer with an expertise in essential health service issues to evaluate the proposals on the criteria established by the CHRC and submit recommendations to the Commission about which applicants should be invited to the CHRC Board meeting in February 2018.**

**Deliverables:** An independent reviewer will be hired to evaluate the proposals on the six criteria established by the CHRC and submit recommendations regarding which applicants (approximately 3-4) should be invited to present to the CHRC in February 2018. Following are the two deliverables of the independent reviewer, which are both due to CHRC staff no later than **January 11, 2018**: (1) evaluate each application on the six review criteria on a 100-point scale and provide a numeric score on the 100-point scale for each proposal. CHRC staff will provide a review sheet that will enable the reviewer to provide a score on each of the six criteria which will comprise the overall score (on the 100 point scale). A single review sheet and score will be provided for each proposal reviewed; and (2) provide an overall assessment (normative evaluation) of each proposal received and include a recommendation whether the applicant should be invited to present to the CHRC in February 2018. This “cover memo” (deliverable #2) should be approximately 3-5 pages, depending on the number of proposals reviewed (about 3-5 sentences per proposal).

Independent reviewers cannot be affiliated or connected with any of the entities applying for the Commission grants, either in a direct employment, contractual, or consulting role.
