CHRC Background & Mission

Created by Maryland General Assembly in 2005:

- 1. Expand access to health care in **underserved communities**;
- 2. Support projects that serve **low-income Marylanders**, regardless of insurance status; and
- 3. Build capacity of safety net providers.

Maryland Health Equity Resource Act

Pathways to Health Equity Program

- Two-year grants to be issued by CHRC.
- Applicants should demonstrate selfsustainability as a HERC.
- Provides foundation and guidance to become a HERC.

Health Equity Resource Communities

- Five-year grants.
- Emphasizes longer term interventions that address SDOH:
 - Housing;
 - Transportation;
 - Employment;
 - Food Security.

Pathways to Health Equity Call for Proposals

Pathways applicants need to demonstrate how:

- 1. The program will address each of the following five policy objectives:
 - A. Reduce health disparities (see next slide);
 - B. Improve health outcomes;
 - C. Improve access to primary care;
 - D. Promote primary and secondary prevention services; and
 - E. Reduce health care costs and hospital admissions and re-admissions.
- 2. Demonstrate how the proposed Pathways program could be "self-sustainable" as a Health Equity Resource Community.



MD Health Equity Resource Act Definition of Health Disparity

"Health Disparity" means a particular type of health difference, such as a difference in rates of:

- Hypertension
- Asthma
- Substance Abuse
- Maternal and Infant Mortality

- Heart Disease
- Diabetes
- Mental Health Disorders

"Applicants will have the flexibility to tailor their focus to address the identified needs of the proposed geographic area and target population. (page 8, of the Pathways to Health Equity Call for Proposals)



Geographic Definition of HERC

Contiguous geographic area that:

- 1. Measurable and documented disparities and poor health outcomes;
- Small enough to allow for incentives to have a significant impact on improving health outcomes & reducing health disparities including:
 - a. Racial
 - b. Ethnic
 - c. Geographic &
 - d. Disability related disparities
- 3. Has a minimum population of 5,000 residents



Pathways / HERC Eligible Entities

The following entities are eligible to apply:

- 1. Nonprofit, community-based organization;
- 2. Nonprofit hospital;
- 3. An institution of higher education;
- 4. Federally Qualified Health Center; or
- 5. Local Government Agency (i.e., Local Health Department).
- The CHRC intends to use the HERC applicant eligibility requirements for the Pathways RFP



Partner, Partner!

- Applicants are strongly encouraged to develop coalitions to achieve the objectives of the Act.
- Community-based organizations and other community groups are encouraged to partner with an eligible entity as the lead applicant.
- Examples of entities that should be contacted: Historically Black Colleges and Universities (HBCUs) and Local Health Improvement Coalitions (LHICs).
