PUBLIC SESSION MINUTES

The Public Meeting of the Commission on Kidney Disease was held on Thursday, May 3, 2018 at 4201 Patterson Avenue. Chairman, Dr. Jeremy Yospin called the meeting to order at 2:06 P.M. I. RATIFY APPROVAL OF THE MINUTES OF THE PUBLIC SESSION OF JANUARY 25, 2018

Dr. Yospin reported that in order to post the Commission meeting minutes to the website in a timelier manner, the Commissioners voted via email after the January 25, 2018 meeting to approve the meeting minutes. Commissioner Wise motioned to ratify the approval of the Public Minutes from the January 25th session. Commissioner Hanes seconded the motion and the Commission voted unanimously to ratify the approval the Minutes of the January 25, 2018 Public Session.

II. REVIEW AND APPROVAL OF THE MINUTES OF THE CLOSED SESSION OF JANUARY 25, 2018

Dr. Yospin reported that in order to post the Commission closed meeting minutes to the website in a timelier manner, the Commissioners voted via email after the January 25, 2018 meeting to approve the closed session meeting minutes. Commissioner Hanes motioned to ratify the approval of the Minutes from the January 25th closed session. Commissioner Segal seconded the motion and the Commission voted unanimously to ratify the approval the Minutes of the January 25, 2018 Closed Session.

III. CHAIRMAN'S REPORT

Dr. Yospin reported on dialysis facility transitional care programs. He noted that patients, new to dialysis, failed transplants and modality changes could be candidates for the programs. Dr. Yospin stated that one third of patients do not receive pre-ESRD care and are "crashing onto dialysis". He noted that dialysis presents a huge change in lifestyle for patients. The first 90 days present patients with increased risk for complications, rehospitalization and possibly death. The large dialysis organizations currently have programs to help patients with transition. The current programs offer education and phone calls to the new patients. Dr. Yospin stated that new transitional care units are being proposed. The programs would offer new patients treatment in smaller settings, often a "setting within a setting". He noted that patients would remain in the transitional setting for 3-4 weeks and receive extensive education including treatment modalities. Some programs may use home hemodialysis machines affording patients more frequent, gentler dialysis. Dr. Yospin reported that 30% more patients are choosing in-home therapy options in this type of setting.

V. OLD BUSINES

Discussion on Proposed Revisions to the Commission's Involuntary Discharge Packet

Dr. Yospin reported that the Involuntary Discharge Packet Subcommittee had not as of yet convened to discuss revision of the Packet but was hopeful that the group would meet in the near future.

VI. NEW BUSINESS

A. Kidney Disease Program

• Dr. Yospin the reviewed the stats and budget report (Attachment C) submitted by KDP. He noted that \$4.5 million is remaining until the end of the fiscal year. .

B. Summary of Dialysis Facility Surveys in Maryland 2012-2016 - Dr. Jaar

Dr. Bernard Jarr, former Commission Chairman and Dr. Ying-Che Huang, a MPA student at Hopkins Bloomberg School of Public Health presented data, analysis and trend information gathered by Dr. Jaar from the Maryland Commission on Kidney Disease surveys conducted from 2012-2016. They concluded that: during those 5 years there had been a decreasing trend in deficiencies per facility between 2012 and 2016. Infection Control, Water and Dialysate Quality, Physical Environment, Patient Plans of Care and Personnel Qualifications/Staffing were the top 5 categories of deficiencies. Laboratory/Affiliation Guidelines, Responsibilities of the Medical Director, Medical Records and Governance deficiencies are the categories of deficiencies that had increased over the years of follow-up; all other categories of deficiencies either decreased or remained constant over time. Within each category of deficiencies, even though the number of deficiencies may vary from year to year, the type and pattern of deficiencies were similar in the observed period. The presentation will be posted on the Commission's website.

C. Refusal of Patients by Nephrology Practices

Dr. Yospin reviewed the Network's Position Statement on Refusal of Patients by Nephrology Practice. He encouraged the guests to make their medical directors and attending physicians aware of the information. Discussion ensued. He noted that the Network's website has a link to the Decreasing Dialysis Patient-Provider Conflict - Provider Manual, which is a good resource.

D. Benefits of Facility Certification versus Impact of Patients in a Non-Certified Facility

Mrs. Adcock reported that recently a patient contacted the Commission to complain that she was dialyzing in a facility that is not certified by the Commission. The patient stated that she needed KDP benefits and did not understand why the facility was not certified. Mrs. Adcock encouraged the group to assure that all their facilities are certified so the patients are not negatively impacted. Dr. Hanes requested that the list of uncertified dialysis facilities on the Commission website be updated.

E. Letter from MDH Regarding Opioid Overprescribing

Dr. Yospin reviewed the attached letter and guidance from the Maryland Department of Health regarding opioid overprescribing for informational purposes.

F. False Negative Hepatitis B Surface Antigen Testing

A case study from Morbidity and Mortality Weekly Report was discussed by Dr. Yospin. The case study emphasized the need for dialysis facilities to assure that their laboratories and laboratories where they accept Hepatitis B testing are using FDA approved assays that detect HBsAg mutants.

G. Network Update - Dialysis Event Surveillance

Mrs. Adcock reported that the Networks are required by CMS to track facility dialysis event surveillance training. Their goal is for 90% of the facilities to have completed the training by the end of the third quarter. Facilities are required to fax the completed surveillance training certificates to the network. Each facility must have at least one person who is surveillance trained. The person will hold the Secure Access Management Services (SAMS) card. The Network recommends that more than one person per facility be trained. They have requested that the surveyors validate dialysis event surveillance training completion, speak with the facility's SAMs card holder and see their certificate of completion.

H. Discussion Regarding the Assigning of an Infection Control "Officer" in a Facility

Mrs. Schwartz briefly discussed the concept of having each facility assigning a person who would be responsible for infection control in the dialysis facility. She will elaborate further at the July commission meeting.

Dr. Yospin directed the guests' attention to the Commission's annual Newsletter. He reported that the Newsletter had been distributed to the renal community and is also available on the Commission's website.
