MINUTES OF THE PUBLIC SESION

The Public Meeting of the Commission on Kidney Disease was held on Thursday, January 24, 2013 at 4201 Patterson Avenue. Chairman Dr. Luis Gimenez called the meeting to order at 2:10 P.M. I. REVIEW AND APPROVAL OF THE MINUTES OF THE PUBLIC SESSION OF October 25, 2012

Mr. Frederick motioned to approve the Public Minutes from the October 25th session; Dr. Modi seconded the motion and the Commission voted unanimously to approve the Minutes of the October 25, 2012 Public Session.

II.REVIEW AND APPROVAL OF THE MINUTES OF THE EXECUTIVE SESSION OF October 25, 2012

Mrs. Adcock read the minutes from the October 25, 2012 Executive Session. Dr. Weir motioned to approve; Dr. Jaar seconded the motion and the Commission voted unanimously to approve the Minutes of the October 25, 2012 Executive Session.

III. CHAIRMAN'S REPORT

Dr. Gimenez directed the guests' attention to the numerous citations under the infection control category. He encouraged everyone to redouble efforts to improve quality of care and safety for patients.

Dr. Gimenez reported on the expanding role of physician extenders in the dialysis environment. He stated that the supply of nephrologists will decrease in the years to come and noted that he would discuss this topic formally later in the meeting.

IV. EXECUTIVE DIRECTOR'S REPORT

Mrs. Schwartz thanked everyone for attending the meeting.

V. OLD BUSINESS

A. Medical Orders for Life Sustaining Treatments www.marylandmolst.org

Mrs. Fagan reported that the MOLST regulations will become effective on 7/1/13. Beginning on this date, dialysis facilities will be required to complete the forms on newly admitted patients. Mr. Frederick noted that the MOLST instructions require annual review of the form. Discussion ensued. Dr. Gimenez suggested that the required review could be accomplished during the patient plan of care conferences.

B. Proposed Changes to the OHCQ Regulations—COMAR 10.05.04

Mrs. Fagan reported that the OHCQ regulations have a projected Maryland Register publication date of 2/8/13, with an effective date of 2/18/13. It was also reported that these regulations will be adopted with non-substantive changes that would clarify that the kidney dialysis center is only expected to include in its emergency plan all possible measures to avoid disruption of kidney dialysis services rather than being expected to act as a guarantor that no disruption of services will occur despite preparing the strongest possible emergency plan.

C. Pilot Study to Reduce Bloodstream Infections

Dr. Lisa Lubomski reported that she is still waiting for final approval from the JHH IRB for the brochure and enrollment documents. She noted that once the documents are approved an expert panel consisting of representative from dialysis facilities including, nurses, PCTs, patients, nephrologists and quality improvement coordinators would be formed. She hopes the first meeting will take place in late February. Ms. Lubomski stated that the results from the Davita pilot study have not been summarized and therefore not available for discussion.

V. NEW BUSINESS

A. Kidney Disease Program - Stats and Budget

Ms. Manning presented the KDP statistics and budget.

Process for KDP enrollment

Ms. Manning stated that all newly certified dialysis facilities must contact Medical Assistance Enrollment to enroll in KDP. Medical Assistance will then send the facility the enrollment application. She reported that this enrollment process has been in place for the past 4-5 years and that she would assure that the Medical Assistance Enrollment phone number would be placed on the KPD website.

B. Best Practices – Healthcare Acquired Infections

Dr. Vicki Lewis from Medstar's National Center for Human Factors in Healthcare presented "A Systems Approach to Tackling HAIs in an Ambulatory Dialysis Unit". The study produced the development of 10 interventions to decrease risk of HAIs in the dialysis facility.

C. Maryland Board of Nursing Update

Mrs. Adcock reported that A'lise Williams, RN, Director of Nursing Practice at the Maryland Board of Nursing notified the Commission that the board is considering removing specialty certifications from the CNA. This would include the CNA-DT. Mrs. Adcock urged the guests to contact the provided list of interested members of the board with concerns/comments.

D. Network Report

Octavia Wynn and Renee Bova Collis were present to report highlights of the Network's activities. Ms. Wynn noted that there would be two learning and action networks formed with a kickoff date of 2/28/13, 99% of Maryland facilities are enrolled in NHSN, 100% of Maryland facilities are enrolled in Crown Web, a vascular access project will be initiated, and a virtual council meeting webinar would be conducted in February. Ms. Wynn reported that all of the above information is available on the MARC website.

Ms. Bova-Collis noted the Network received 85 contacts (patient concerns) last year. She reported that most complaints arise from staff interactions and perceived quality of care issues. She stated that facilities with a number of complaints may be selected for interaction. Ms. Bova-Collis discussed involuntary patient discharges. She noted that

most involuntarily discharged patients are able to be placed in the community. There is an emphasis in decreasing involuntary discharges; tools are available on the Network's website.

Discussion ensued.

E. Physician vs. Physician Extender Rounding/Charting

Dr. Gimenez reported that nephrology training positions are going unfilled and that the ESRD population is on the rise. He noted that physician extenders will be a reality and discussed the roles of the extenders in the dialysis facilities.

Discussion ensued. The Commissioners agreed that supervision and training of the physician extenders is key to providing quality care to the patients.

F. Proposal to Update Commission Regulations

Mrs. Schwartz noted that, once the OHCQ regulations (COMAR 10.05.04) become final, the Commission will amend its regulations for consistency purposes. She requested to defer the topic until next meeting when the OHCQ regulations are final.

G. Governor's Report

Mr. Frederick motioned to approve the submitted Governor's Report and Dr. Modi seconded the motion. The Commission voted unanimously to approve the report.
