# MARYLAND COMMISSION ON KIDNEY DISEASE OPEN SESSION MEETING MINUTES Thursday July 22, 2010 4201 Patterson Avenue. Room 108-109

The Open Session meeting of the Commission on Kidney Disease was held on Thursday, July 22, 2010 at 4201 Patterson Avenue in room 108-109. The Chairman, Dr. Jeffrey Fink called the meeting to order at 2:12 PM. Commission members present were: Drs. #### I. APPROVAL OF April 22, 2010 MINUTES

The minutes were approved as submitted.

#### II. CHAIRMAN'S REPORT

Dr. Fink welcomed everyone to the meeting. He discussed a news magazine's article about safety, how safety practices vary in the United States and the benefits of regulation and oversight. He noted that we must establish and maintain strict guidelines to avoid poor outcomes.

# III. EXECUTIVE DIRECTOR'S REPORT

Mrs. Schwartz welcomed everyone and introduced Dr. Weir as a member of the Commission.

#### IV. OLD BUSINESS

#### A. Veterans Administration Update on Contacts – Dr. Jeffrey Fink

Dr. Fink reported that after the VA solicitation, local and national providers were selected to be providers for the VA. He noted that locally, Davita, FMC and IDF were chosen.

Ms. Mooney reported that the contract with the VA requires submission of care plans on VA patients to the VA.

#### B. Life Safety Code

Ms. Fagan reported that the Life Safety Code requirement for new and relocating dialysis facilities have been in effect since February 2009. In December 2010 the Office of Health Care Quality has been directed by CMS to survey dialysis facilities for Life Safety Codes when performing recertification surveys. Ms. Fagan stated that the 2000 NFPA guidelines would be utilized and that the State Fire Marshal would be conducting the Life Safety Code portion of the survey.

# C. KDP Formulary Recommendations

Dr. Kraus reported on the work of the subcommittee regarding KDP Formulary recommendations. He noted that the subcommittee includes three expert pharmacists who have been reviewing the formulary for safe, appropriate, effective and affordable drugs. Dr. Kraus stated that he hopes the work will include an educational component for the dialysis facilities.

Mr. Simon inquired about the time frame for completion. Dr. Kraus noted that no specific time frame has been established and that the subcommittee's goals were evolving.

Dr. Fink stated that he would like to develop a timeline.

Mrs. Schwarz noted that the subcommittee was formed to proactively address any cuts that may be required of the KDP budget. While working on this task, the subcommittee has discovered that there should be changes made to the formulary to develop a safe and current list. She noted that the public would have an opportunity for comment on the proposed changes, if applicable.

# V. NEW BUSINESS

## A. Kidney Disease Program - Stats and Budget

Ms. Manning presented the KDP budget.

Dr. Fink inquired what the line item Physician/Special Projects included. Ms. Manning reported that that category includes dental work for pre-transplant work up, one time eyeglass provision, and special requests.

# Removal of Alcon Drugs from the KDP Formulary

Ms. Manning noted that the drugs identified below have been removed from the KDP formulary after the manufacturer, Alcon, decided not to provide the required rebate to the KDP. She noted that there are comparable medications on the formulary. The removed drugs are:

- Betoptic Eye Drops
- Carteolol Eye Drops
- Timolol Eye Drops and Gel Solution

#### B. Bill Cole, Norvartis, Request to Add Transplant Drug, Zortress, to the KDP Formulary

Monica White, pharmacist for Norvartis, presented information on Zortress. Information included risks and benefits of Norvartis' new immunosuppressant agent. Norvartis is requesting the addition of Zortress to the KDP formulary.

Ms. lacovelli, representative from Norvartis, discussed patient assistance programs available for Zortress.

Dr. Fink inquired about the availability of therapeutic drug monitoring for Zortress. Ms. White noted that the therapeutic drug monitoring testing is not currently commercially available but that Norvartis was working with the transplant centers to identify ways to monitor the therapeutic drug levels.

Dr. Kraus voiced his concerns regarding the inability to monitor levels of this drug. Norvartis representatives were asked to keep the Commission informed when monitoring testing will be readily available and accessible to all those interested in using the drug in any setting.

# C. Eligibility of ESRD Patients in Managed Care

Ms. Ruppert, Executive Director for the Office of Eligibility Services Medical Care Programs, reported on her office's outreach efforts to ESRD recipients who may be eligible for Medicare. She noted that her office would be sending letters to recipients and renal social workers to notify them of the requirement for the recipients to provide proof of application for Medicare. Ms. Ruppert also noted that as of August 1, 2010, Medicaid would not be paying the part B Medicare coinsurance or co-payments. A copy of a memo sent to providers regarding the elimination of the co-payments was provided to the group.

A discussion ensued.

## D. Emergency Preparedness – Transportation Services

Chris Simon reported on the Emergency Preparedness and Response: Dialysis Clients, Medical Services and Transportation Services meetings. He noted that these meetings were initiated in response to the weather crisis last winter. The group is working to improve service to the dialysis patients during crisis. Mr. Simon noted that representatives are mostly from Baltimore City, Baltimore County and Anne Arundel County. He stated that the group is discussing Web Emergency Operations Center access for the dialysis providers. A demonstration is scheduled during the group's next meeting on September 30<sup>th</sup>.

# E. CMS Requirement – New Patient Nursing Assessments

Mrs. Adcock directed the group's attention to the attachment from the CMS ESRD Regulations. She noted that the regulation requires that the Medical Director assure that dialysis orders are written and a specific nursing assessment is performed for new patients prior to the initiation of treatment in the outpatient facility.

## F. Dialysis Access Clamp Usage Policy and Procedure

Mrs. Adcock noted that the Network has provided the Clamp Usage Policy and Procedure, which was developed in support of Fistula First. She noted that the policy prohibits the use of clamps on new or underdeveloped fistulas, only one clamp should be used at a time and that the presence of bruit/thrill must be monitored every 10 minutes while the clamp is in place.
