MINUTES OF THE PUBLIC SESSION

The Public Meeting of the Commission on Kidney Disease was held on Thursday, October 25, 2012 at 4201 Patterson Avenue. Chairman Dr. Luis Gimenez called the meeting to order at 2:08 P.M. Commissioners Dr. Kulwant Modi, Dr. Matthew Weir, Dr. Edward Kraus, Dr. Bernard Jaar, James Stankovic, Belinda Lindsay, LGSW, William Frederick, RN and Kim Sylvester, R.N. were also present.

I. REVIEW AND APPROVAL OF THE MINUTES OF THE PUBLIC SESSION OF July 26, 2012 Dr. Modi motioned to approve the Public Minutes from the July 26th session; William Frederick seconded the motion and the Commission voted unanimously to approve the Minutes of the July 26, 2012 Public Session.

II. CHAIRMAN'S REPORT

Dr. Gimenez reported that facilities should be preparing for Hurricane Sandy which is approaching the East coast. He requested that facilities address emergency plans with patients and notify facility municipalities.

III. EXECUTIVE DIRECTOR'S REPORT

Mrs. Schwartz addressed the high frequency of Personnel Qualification/Staffing citations. She reiterated the importance of maintaining appropriately trained and qualified staff. Mrs. Schwartz reminded guests that they must be prepared to adequately staff their facilities and have plans to cover staff absences. She noted the importance of staff following physician prescriptions.

IV. OLD BUSINESS

A. Medical Orders for Life Sustaining Treatments www.marylandmolst.org
Ms. Neville reported that the original MOLST regulations were originally posted in the Maryland Register in September 2011. She noted that there were substantive changes after the public comment period and the Department withdrew the original proposal. On August 10, 2012 the revised regulations were published with a comment period. Ms. Neville stated that the regulations may be effective by the end of this year. The Commission will notify facilities of any updates.

B. Draft - Proposed Changes to the OHCQ Regulations

Ms. Fagan reported that the draft OHCQ regulations will be posted in the November Maryland Register. She noted that nocturnal dialysis, emergency preparedness and patient plan of care regulations would be addressed in the proposed regulations. Mrs. Schwartz stated that, to be consistent, when the updated OHCQ regulations are final the Commission would propose changes to their regulations.

C. Pilot Study to Reduce Bloodstream Infections

Dr. Lubomski reported that they have received approval to expand the study from the Maryland Patient Safety Center and Johns Hopkins. The group is awaiting approval of the brochure from the Johns Hopkins Institutional Review Board. Dr. Lubomski noted that they are currently working with Davita facilities to reduce bloodstream infections, to increase patient safety and improve teamwork in the facilities. Once approved, the pilot would expand to other, non-Davita, Maryland facilities who would be involved in the yearlong project. She stated that the first 30 facilities to respond would be accepted. Dr. Gimenez noted that there should be a broad geographic representation. Dr. Lubomski reported that there should be preliminary information from the Davita study to report at the January 2013 Commission meeting.

V. NEW BUSINESS

A. Kidney Disease Program - Stats and Budget

Ms. Manning presented the KDP statistics and budget.

B. Life Safety Code Update

Ms. Fagan discussed the CMS Mission and Priority Document issued in July. She noted that the ESRD Life Safety Code inspections are now required only for new facilities that do not exit to grade or those new facilities that are located adjacent to industrial high-hazard occupancies.

Discussion ensued. Ms. Fagan reported that facilities are still required to meet local and State requirements for fire safety.

C. Network Statement of Work for 2013-2016

Ms. Vinson introduced the Network's Statement Work which will commence January 2013. She reviewed the three "Aims" which should provide better care and better health along with reduced costs of ESRD care by improving care. She discussed the Network's plans to achieve the goals.

D. Best Practice - Infection Control

Ms. Simmons, RN, Clinical Educator for Good Samaritan Hospital Dialysis presented best practices utilized by the facility to reduce infections. She reported that the facility participates in the CDC Dialysis BSI Prevention Collaborative. Their best practices focus on hand hygiene, catheter care, patient education, staff education and competency and catheter reduction.

- Patient complaint regarding caregiver
- Facility complaint regarding county transportation system
- Facility complaint regarding readmitting a patient from the hospital that requires restraints
