Dear Mr. Choudhury:

Because of the impact of the COVID-19 pandemic over the last 18 months, many Maryland school-aged children may not have been vaccinated in accordance with recommended immunization schedules and as required to attend schools under the Code of Maryland Regulations (COMAR) 10.06.04.03 *Required Immunizations*. As such, these children are at risk of exclusion from school. It is my understanding that in order to provide additional time for children to meet the requirements, a number of local education agencies have requested flexibility in enforcement of the provisions of COMAR 10.06.04.03 E&F and 10.06.04.06 that require school systems, within certain deadlines, to obtain documentation that each admitted or retained student has received certain required immunizations.

I am willing to extend the deadlines set forth in those regulations under the following conditions:

- 1) If a local education agency lacks documentation, required to avoid exclusion under COMAR 10.06.05.06, that more than 250 of its admitted or retained students have received required immunizations under COMAR 10.06.04.03 E&F, the local education agency may request, by Friday, September 24, 2021, that the Secretary grant a one-time extension of 45 days for non-compliant students to be brought into compliance. The request should include the total school enrollment numbers and the total number of students, by grade level, who are non-compliant.
- 2) During the 45-day extension, the local education agency may permit non-compliant students to remain in school and students who have been excluded from school to return to school.
- 3) Any local education agency requesting an extension must submit, by October 1, 2021, an action plan that outlines how the local education agency will:
  - a) Seek to identify all students lacking required immunizations;
  - b) Establish cooperative programs with the local health department, school based health centers, and/or other medical providers to provide access to immunization services and the required proof of immunization;

- c) Implement the intensive outreach efforts needed to bring students into compliance; and
- d) Determine the extent to which additional legal interventions are needed to assure that parents and other caregivers comply with the State's compulsory education and immunization laws and regulations.
- 4) Any local education agency requesting an extension must submit, by October 15, 2021, a report demonstrating the agency's progress by that date in implementing its plan and achieving compliance with COMAR 10.06.04.03 E&F.
- 5) By November 12, 2021, the agency must submit a final report demonstrating its compliance by that date with COMAR 10.06.04.03 E&F and a plan to prevent the need for similar extensions in future years. Elements of the plan should include how the agency will review records to identify non-compliant students earlier, (including establishing agreements with the state's Health Information Exchange to provide student rosters to enable automated review), intensive outreach efforts, and greater access to immunization services; and
