SUPPLEMENTAL ORDER

On November 1, 2012, the Maryland Board of Examiners of Psychologists (the "Board") entered into a Consent Order with Mark Palmisano, Ph.D., License No. 03154, based on violations of the Maryland Psychologists Act. Pursuant to the Consent Order, Dr. Palmisano's license to practice psychology was suspended for a period of two years, during which he was required to enroll in and complete a Board-approved ethics tutorial and complete a Board-approved law course. The Consent Order further provided that upon compliance with the terms of the suspension, Dr. Palmisano's license would be placed on probation for a period of two years, during which he would pay a fine of two thousand five hundred dollars (\$2,500) to the Board and submit to further peer review of his practice, as determined by the Board. On or about October 31, 2014, the Board received a report from Dr. Palmisano's ethics tutor, indicating that Dr. Palmisano had successfully completed his ethics tutorial. As a result, the Board has determined that Dr. Palmisano is in full compliance with the terms of his suspension.

ORDER

It is this 7th day of November, 2014, by an affirmative vote of the Maryland Board of Examiners of Psychologists, hereby:

ORDERED that the suspension of Dr. Palmisano's license to practice psychology in Maryland, License No. 03154, be lifted; and be it further,

ORDERED that in accordance with the Consent Order dated November 1, 2012, Dr. Palmisano's license be placed on immediate PROBATION for TWO (2) YEARS, during which he shall:

- 1. Obtain clinical supervision of his practice of psychology with a Board-approved psychologist supervisor, meet with his psychologist supervisor on an at least monthly basis (with the exact duration and frequency of supervision to be determined by his supervisor), and ensure that his psychologist supervisor submits quarterly performance reports to the Board, and
- 2. Pay a fine in the amount of two thousand five hundred dollars (\$2,500), payable to the Board; and be it further,

ORDERED that after two (2) years of probation, Dr. Palmisano may petition the Board to terminate probation, provided that he has been fully compliant with the terms of probation, his supervisor's quarterly performance reports indicate that he is practicing psychology ethically and competently, and he does not have any pending complaints filed against him; and be it further,

ORDERED that Dr. Palmisano shall at all times cooperate with the Board in the monitoring, supervision, and investigation of his compliance with the terms and conditions of this Order; and be it further,

ORDERED that Dr. Palmisano's failure to fully cooperate with the Board shall be deemed a violation of the probationary terms and a violation of this Order; and be it further,

ORDERED that in the event the Board finds in good faith that Dr. Palmisano has violated any of the conditions of probation herein, or in the event the Board finds in good faith that Dr. Palmisano has committed a violation of the Maryland Psychologists Act or regulations adopted thereunder, the Board may take further disciplinary action against Dr. Palmisano's license after notice and the opportunity for hearing; and be it further,

ORDERED that Dr. Palmisano shall bear the expenses associated with this Order; and be it further,

ORDERED that this is a formal order of the Maryland Board of Examiners of Psychologists and as such is a public document pursuant to Md. Code Ann., General Provisions § 4-333(b).
